HOW TO ENTER: Become a member of Brunswick's Ripl online boating community during the Sweepstakes Period. Becoming a member of Ripl is free; Ripl membership has no obligations, and members may end their membership at any time.

Information about Ripl and how to become a Ripl member can be found at www.brunswick.com/Ripl. Once at the website, you will be required to complete the following steps. First, you will be asked to provide your full name, email, and phone number, as well as complete a short form, which will include questions relating to:

- how important the water is to you;
- activities you enjoy participating in;
- if you use a boat to enjoy the water; and

• if you are a boat owner or boat club member, which brand of boat you own or which boat club you belong to.

After you submit the form, you will receive an e-mail with a link to complete a survey, which includes answering questions that have been selected based on your responses to the form on the initial landing page. Specifically:

- **Boat Owners** will answer questions about their current boat(s), such as if you own more than one, what type it is, size, the type of water you go boating in (freshwater/saltwater), model, whether you purchased the boat new or used, how you store your boat, favorite features, if you would recommend the brand, your boat ownership history, what a new boat purchase would ideally include and look like, challenges you've experienced as a boater, and what your boating future might include.
- Club Members will answer questions about their club membership such as what year you joined, types of boats most often used, the type of water you go boating in (freshwater/saltwater), how long it takes to get to your club, why club membership was best for you versus buying a boat, if you would recommend your club, your boating history, if you were buying a boat what that would ideally include and look like, what would you need to be true for you to make a purchase, and what your boating future might include.
- Everyone else will answer questions about prior ownership/club membership (if applicable), how you go boating now, type of boat most often used, the type of water you go boating in (freshwater/saltwater), rental experience, if you were buying a boat what that would ideally look like, comfort level driving a boat, your barriers to ownership, what would need to be true for you to make a purchase, and what your boating future might include.

Finally, everyone will be asked to provide (optional) certain demographic questions, such as age range, gender, location, ethnicity, household income, and if you are interested in participating in future surveys via SMS message (also optional; if interested, you will be asked to provide a valid telephone number).

Once you have submitted the form AND completed the survey, you will be entered into the Sweepstakes. Responses provided by participants will not be judged, and the quality of responses provided will not affect a participants' ability to enter.

Limit one (1) entry per person. All entries must be received by 11:59 pm EST on March 31, 2025. Entries that are lost, late, illegible, corrupted, mechanically produced, misdirected, falsified, mutilated, damaged, altered, or otherwise irregular will be void and disqualified at Sponsor's sole and absolute discretion.
